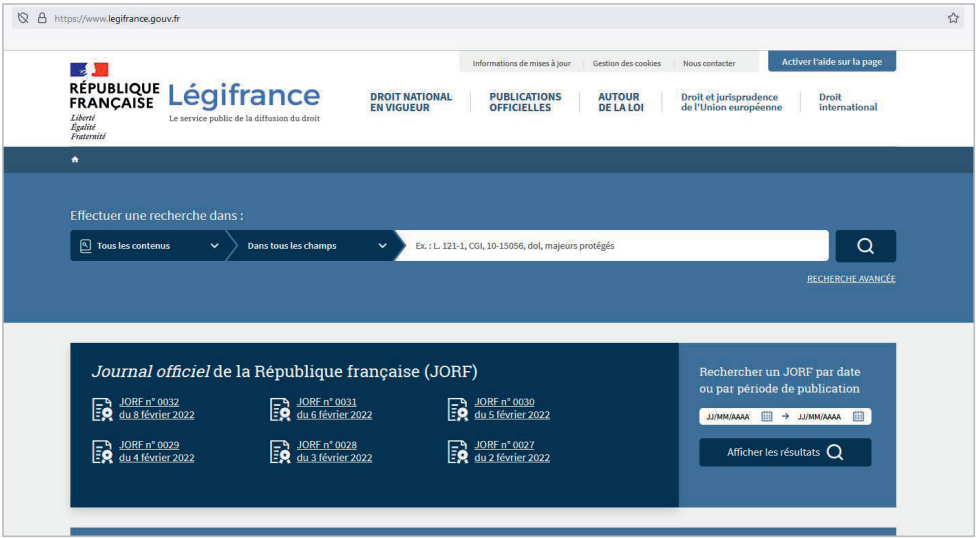

The State service for the public communication of the law

Legifrance.gouv.fr, instituted by Decree No. 2002-1064 of 7 August 2002, is aimed at facilitating public access to the essentials of the law. It consequently offers access to the Official Gazette of the French Republic (JORF), codes, legislative and regulatory enactments (laws, orders, decrees, orders, decisions, etc.), case law and collective agreements. It also provides access to deeds of a normative nature, deeds resulting from France’s international commitments and a series of official publications.

The site, modernised in 2020, has been enriched with new content such as access to Official Gazettes since 1869 and new services such as «Chrono Légi» [Legislative Chronicle] and «Le comparateur de versions” [Version Comparison Engine], which make it possible to track the evolution of an enactment or article over time. The site includes application programming interfaces (APIs) for consultation in order to facilitate data reuse.

The DILA also sees to the legal communication of civil and commercial announcements, public procurement announcements and other mandatory legal announcements on the sites bodacc.fr, boamp.fr, and journal-officiel.gouv.fr.

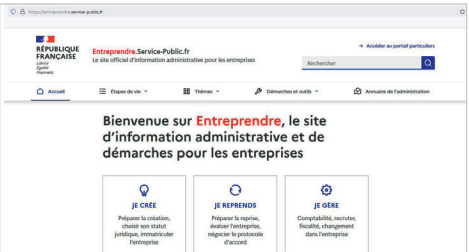

Created in 2000, service-public.fr is dedicated to informing users and directing them to the services at which they can find out about their obligations, exercise their rights and complete their administrative procedures with the relevant administration services. It enables users to carry out many everyday procedures on-line, create their personal account, and gain access to situation simulators, personalised guided searches and the administration directory (70,000 local public service one-stop offices).

Since March 2022, entreprendre.service-public.fr has been serving entrepreneurs from small and medium-sized enterprises and the self-employed, and offers the information they need for their

administrative procedures as well as knowledge of their rights and obligations.



The site references all mandatory procedures, by theme, by stage in a company’s life, according to logical and adapted pathways and offers easy access to them.

As part of its general remit to give citizens access to public life and public debate, the vie-publique.fr website informs and elucidates about the functioning of the institutions and public policies and provides the keys to understanding the major subjects that drive public debate through fact sheets, multimedia documents, news and its collection of public speeches and reports.

vie-publique.fr contains the catalogue of editions La Documentation française, the public sector’s publishing house since 1945, with more than 1,900 references, including books (Doc en poche, Découverte de la vie publique), journals (Cahiers Français, Questions internationales), and fine books (The Constitution, Women and the Republic) aimed at public players, teachers and students, and the general public. Through this contribution to public understanding of the contemporary world, the content published contributes to democratic debate and citizen formation.
